**TERMS AND CONDITIONS:**

- All booths must be self sufficient. You are responsible for bringing all equipment for your display space (tent, canopy or covering, adequate weight supports, chairs, display cases, etc.) No staff,/materials will be supplied by event organizers.
- Event is rain or shine.
- All booths must set up by 9:30am. Failure to appear one hour prior to the official start of base camp may result in forfeiture of your booth location.
- Load in time is between 6:30-9:00am. Everyone must load in during this time and all vehicles must be moved from booth area by 9:30am.
- Booths are expected to remain set up until 3:00pm.
- You and/or your company are/is solely responsible for the content of the booth and the security of the goods and quality of the services provided by this booth. TrailDays and its producers will not supervise your booth in your absence.
- You cannot charge attendees for booth activities. (For example: You will not be allowed to have a dunking tank in which patrons must pay to participate. They will have to play for free.)
- All applicants agree that by entering into TrailDays, your company's name, logo and event photos can be used in TrailDays promotional efforts.
- All applicants agree to abide by all Town of Silver City and CDTC TrailDays rules and regulations. Any violations of rules and regulations set forth will result in immediate dismissal from the CDTC Base Camp.
- CDTC reserves the right to decline applications if they conflict with event sponsors. If application is declined, applicant will be notified immediately and all entry fees will be refunded.
